Application Instructions

Chrome may be applied to all types of crops including but not limited to: Field Corn, Seed Corn, Popcorn, Sweet Corn, Rice, Soybeans, and Wheat as a foliar application at a rate of ½ to 3 gallons per acre during grain or pod fill. Chrome may be applied undiluted or diluted (with water) for aerial or ground application. Use sufficient carrier to adequately cover crop foliage. Caution: Plant and leaf injury may occur on some crops when certain weather and growing conditions are present.

Compatibility

Chrome is compatible with most common foliar liquid nutrients and micronutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.

Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
