Application Instructions

Chrome^{SR} can be applied to all crops, including but not limited to: field corn grown for seed, popcorn and sweet corn. Apply 1 to 3 gallons per acre to crops during grain fill. Make applications early in the day when it is cool and the temperature is below 80°F. The presence of dew or moisture on the leaves will enhance uptake of this product into the plant.

Compatibility

Chrome^{SR} is compatible with most common foliar liquid nutrients and micronutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.

Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
